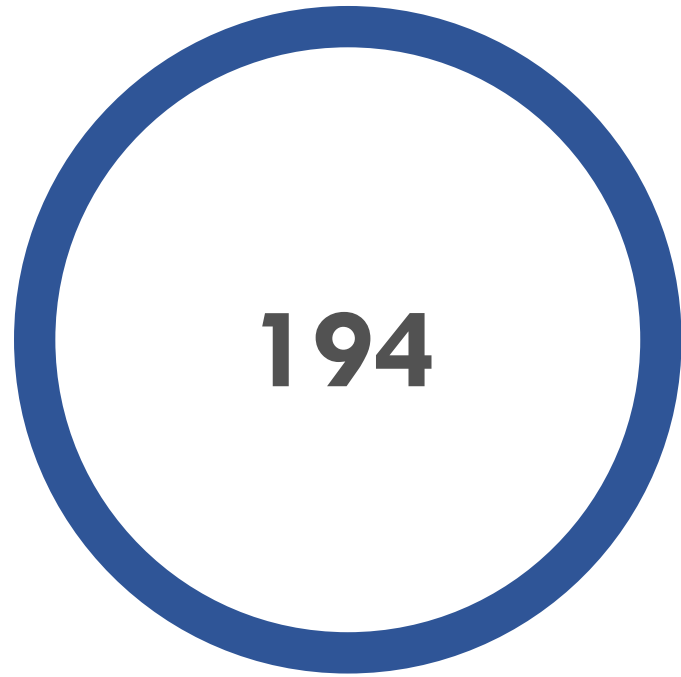

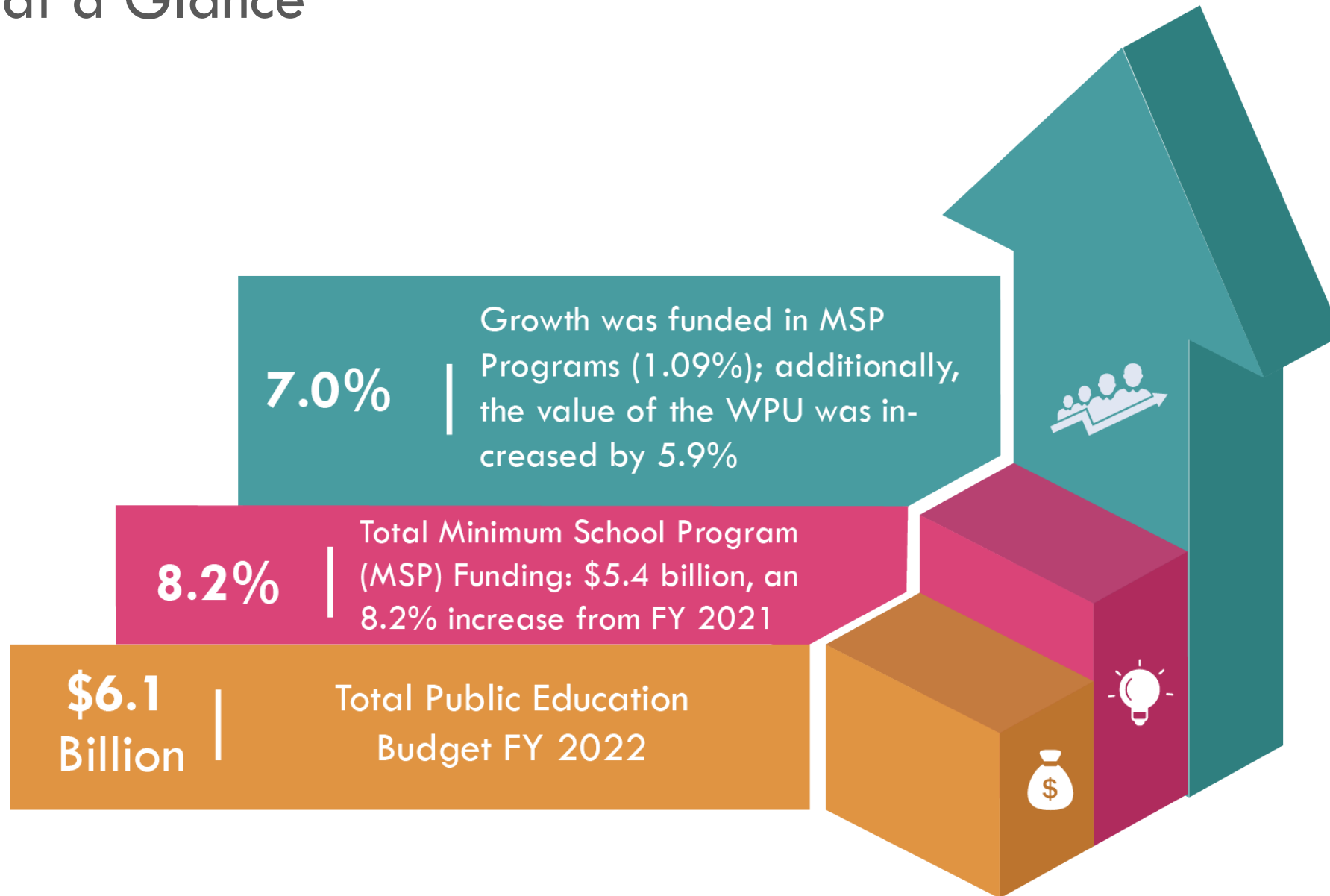

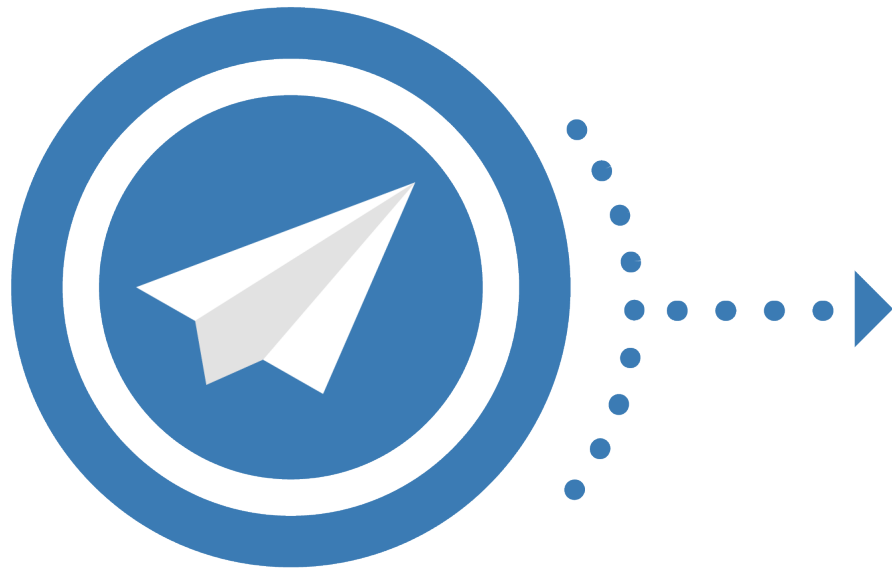
Numbers at a Glance



Enrollment Growth and WPU



\$248,918,500 ongoing and **\$48,239,500** one-time. This funding includes the WPU value increase. Local Education Agencies (LEAs) will be funded on the prior year Average Daily Membership (ADM) + growth. Enrollment growth was funded for an estimated increase of **7,245** over fall 2020 enrollments. In addition, a contingency fund was created to cover higher than expected growth.



Voted and Board Local Levy Programs Increase

The state guarantees up to a maximum of 20 tax increments (tax rate of 0.002) between the Voted and Board Local Levy Programs with appropriated funds of **\$95.1 million**.

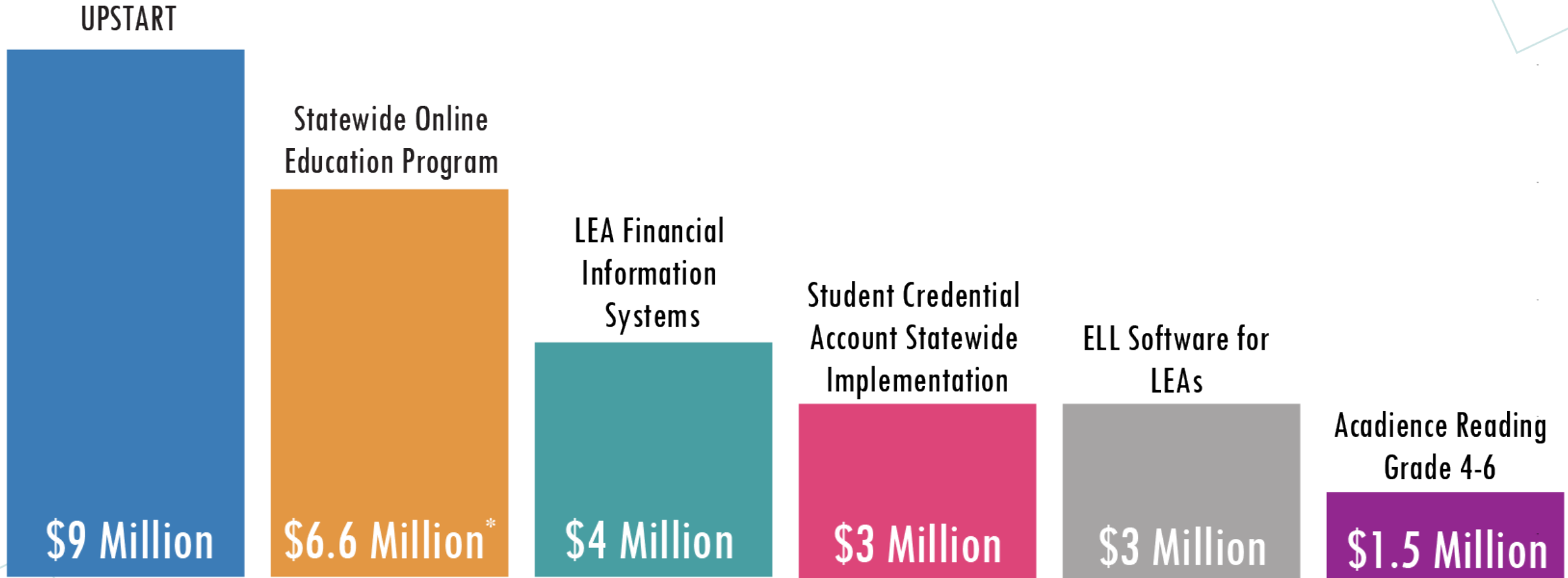

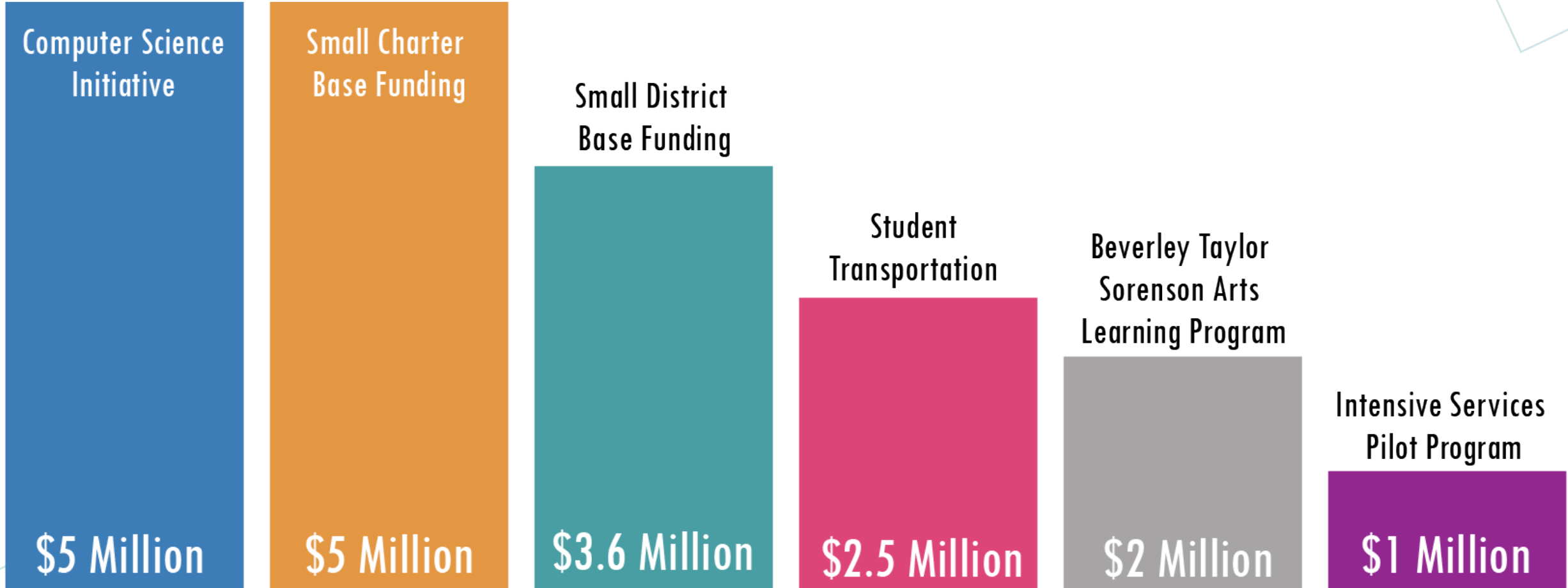

School Assessment and Accountability Amendments

SB 184: Senator Kathleen Riebe



Suspends for the 2020-2021 school year, state school accountability requirements due to the suspension of assessments in Spring 2020.

Notable Education Bills

Grow Your Own Teacher and School Counselor Pipeline Program

HB 381: Representative Jefferson Moss



Creates a three-year teacher and school counselor pipeline pilot program to provide funding to LEAs to award scholarships to paraprofessionals, school counselor assistants, and school counselor interns. USBE will report the results of the pilot program to the Legislature in 2023.

Intensive Services Pilot Program

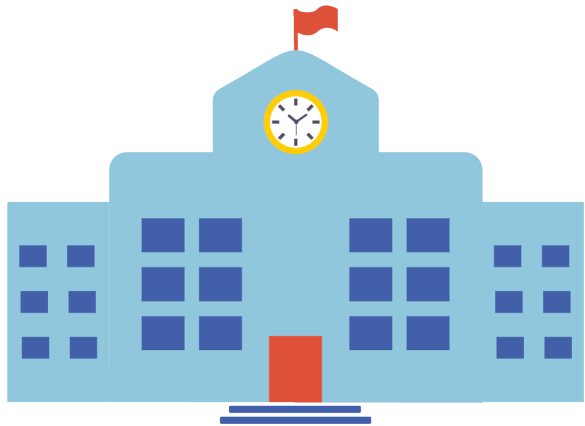
HB 421: Representative Marsha Judkins

Creates the Intensive Services Pilot Program to provide funding to supplement the cost of educating a student for whom the cost of special education services exceeds three times the statewide average per-pupil expenditures.



In-Person Instruction Prioritization

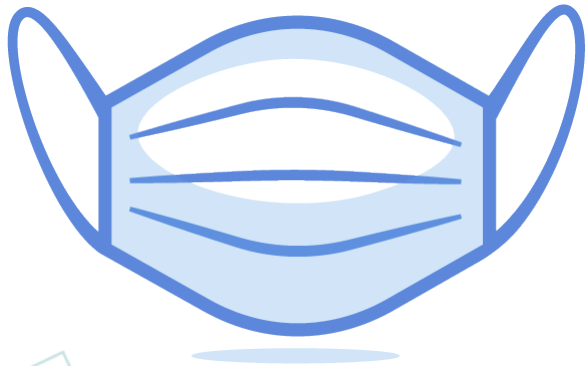
SB 107: Senator Todd Weiler



Requires an LEA to provide an option for students to attend school in-person at least four days per week and amends the COVID case thresholds to **2%** or **30 cases** depending on school size.

Pandemic Emergency Powers Amendments

HB 294: Representative Paul Ray



Eliminates the statewide mask mandate for the majority of the state on **April 10, 2021**. Allows local county commissions and local health authorities to establish mask mandates at the local level. Exempts a statewide mask mandate for K-12 schools from the **April 10, 2021** deadline and sunsets that mandate on **July 1, 2021**.
